1 INTRODUCTION


1.1 Purpose

The purpose of these guidelines is to provide the requirements for the application, obtainment and minimum service delivery requirements for Midstream and Downstream Oil and Gas Industry Service Permits (MDOGISP). These Guidelines are issued pursuant to Section 32(tt) of the Petroleum Industry Act (PIA) 2021 which mandates the NMDPRA to ensure and monitor performance parameters of industry players and the quality of service provided by servicing companies in the midstream and downstream petroleum industry. Furthermore, Section 218 of the PIA 2021 stipulates that a person or company engaged in petroleum operations, which require permit in the midstream and downstream petroleum operations shall register its undertaking with the NMDPRA and provide information concerning the activities of the undertakings.

From the foregoing, pursuant to the above-mentioned sections of the PIA and Regulations 37 of the Midstream and Downstream Petroleum Operations Regulations 2023, no company/person shall render or be engaged by a licensee to render services to the midstream and downstream oil and gas Industry without first being registered and issued a permit to carry out such services by the NMDPRA. Any company that renders services in the midstream and downstream oil and gas operations without an appropriate and valid service permit and any licenses/ operator that engages such company is in contravention and is liable to applicable penalties as prescribed in the Midstream and Downstream Petroleum Operations Regulations 2023.

1.2 Scope

Midstream and Downstream Operations as defined by Section 318 of the PIA 2021 are activities and operations Downstream the Petroleum Measurement Point, whether or not related to a Petroleum Mining Lease. The Licenses for these Operations are contained in Chapter 2 (Part IV & V) of the PIA 2021 for Gas and Petroleum Liquid Operations. These Guidelines therefore are applicable to companies operating in the Nigerian Midstream and Downstream Petroleum Industry and those wishing to render services to a licensee and Operator in the Industry. It covers the different categories of permits in the Midstream and Downstream Petroleum Industry, services available in each category of permit, application procedure, minimum service delivery and applicable sanctions.

2 OVERVIEW OF MDOGISP PROGRAM

2.1 Obtainment Of Appropriate Permit to Render Services

The following applies at the minimum:

- i. Activities which licenses are issued by the NMDPRA for Midstream and Downstream Operations are contained in Chapter 2 (Part IV & V) of the PIA 2021, Midstream and Downstream Petroleum Operations Regulations 2023 and other regulations by NMDPRA.
- ii. It is mandatory for any company wishing to render service under a license in the Nigerian Midstream and Downstream Industry to have the appropriate and valid permit to do so.
- iii. No company shall render or be engaged to render services to the midstream and downstream oil and gas petroleum operations without first being registered and issued a permit to carry out such services by the NMDPRA.
- iv. All Licensees and Operators in the Nigerian Midstream and Downstream operations shall ensure that it engages only service providers with the appropriate and valid permit.
- v. Any company that renders services in the midstream and downstream Oil and Gas operations without an appropriate and valid service permit or any Operator/Licensee that engages a company without an appropriate and valid permit is in contravention and liable to applicable sanctions.

2.2 Categories Of MDOGISP


The categories of permits under which application may be made on the MDOGISP platform to render services in the Nigerian Midstream and Downstream Petroleum Industry, are as follows:

- i. General Category
- ii. Major Category
- iii. Specialized Category.

2.2.1 General Category

The following applies to this permit category.

- a. This category of permit covers:
 - i. Artisanry works and maintenance services that do not require specialised or certified competences or formal bidding process.
 - ii. Minor supplies that are expected not to exceed, Five Hundred Thousand Naira (₦500,000) at a time and usually do not require formal bidding process to engage the supplier.
- b. Fees for permits under the General category are shown in Appendix 1.

c. The details of services and permits related to the General category are depicted in Appendix 2

2.2.2 Major Category

The following applies to this Major Permit category:

- i. Under the Major category, companies are required to possess relevant and verifiable technical skills required for the service.
- ii. Fees for permits under the Major category are shown in Appendix 1.
- iii. Details of services related to Major category of permit are depicted in Appendix 3.

2.2.3 Specialised Category

The following applies to this Specialised permit category:

- i. Under the Specialised Category, companies are required to possess relevant and verifiable technical skills.
- ii. Fees for permits under the Specialised Category are shown in Appendix 1.
- iii. Details of services related to specialised category of permit are depicted in Appendix 4.
- iv. Inspection of premises may apply for some permits under this category.

2.2.4 Unprofiled Services on MDOGISP


The following applies.

- i. The NMDPRA shall endeavour to update the list of services in line with current realities and opportunities in the midstream and downstream industry.
- ii. Where a company fails to find a service that matches with any of the profiled services, the unprofiled services shall be filled in by text by the Company and subjected to review and approval by the NMDPRA.
- iii. The NMDPRA may determine new services or reclassify services from time to time without notice.

2.3 Basic Information on MDOGISP Application

Companies seeking to obtain MDOGISP shall note as follows:

- i. NMDPRA does not encourage the use of proxies in the application process for the MDOGISP and therefore will not indemnify any company (or persons) against any loss arising therefrom.

- ii. A company shall apply for, renew and obtain permits at any time throughout the year for every service it intends to render to the midstream and downstream petroleum industry.
- iii. For every service the company intends to render, it must ensure that it is registered and recognized by Corporate Affairs Commission (CAC) to render such service(s), has the appropriate legal status and the required competencies/capabilities/equipment for such service.
- iv. Successful validation or accreditation of facilities/equipment/materials/processes is mandatory for certain applications such as some HSE related applications and others as may be listed on the portal.

2.4 MDOGISP Fees:


The following applies:

- i. The summary of fees applicable to MDOGISP are as specified in appendix 1.
- ii. Payments can be made directly through any means specified by the NMDPRA on the MDOGISP portal. Further payment instructions are available at the point of payment on the MDOGISP portal.
- iii. Payment does not guarantee the issuance of a permit by the NMDPRA. Permits are issued only after Companies have fulfilled all other necessary conditions stipulated in these guidelines and documents related to MDOGISP.
- iv. Payments are valid for a period of three (3) months effective from the date paid and are non-refundable. Companies are therefore advised to ensure that all required documentation are available and ready for upload prior to application.

2.5 Publishing Of Service Companies

In line with the Section 219 of the PIA 2021, the NMDPRA shall publish details of companies with valid MDOGISP. The publication shall serve the following purpose:

- i. Promotion of Companies on the MDOGISP portal for Operators to easily know how to locate service providers for different services.
- ii. Service directory where an operator or the public can assess the service providers that possess different permits for different services at various locations.
- iii. Support for companies without resources to maintain service database, by serving as easy reference hub for contractor information.

3 APPLICATION REQUIREMENTS FOR MDOGISP

3.1 Overview of Application Procedure


Any company wishing to render services to the Midstream and Downstream Petroleum Industry of Nigeria shall:

- i. Register its company on www.celps.nmdpra.gov.ng.
- ii. Complete its application through www.mdogisp.nmdpra.gov.ng.
- iii. Fill in all the required information and upload all required documents related to the application.
- iv. Pay applicable fees as stipulated in Appendix 1.

The summary of the application steps are as depicted in the table below:

3.2 Provision of Information and Documents on MDOGISP

3.2.1 Application Procedures and Instructions


The following are to be ensured:

- a. All applications shall be duly completed and submitted via the portal. Companies are not required to submit hardcopy documents.
- b. Company must ensure to provide correct and functional addresses (registered and operational), telephone numbers and e-mail at the time of submission.
- c. For Document Upload, the following applies.
 - i. Any document to be uploaded shall be clearly scanned from original documents or certified true copies.
 - ii. All required documents shall be uploaded to the portal in PDF format. PNG or JPEG formats are accepted for single paged documents.
 - iii. Documents to be uploaded on the portal shall not exceed 4MB.
 - iv. Uploading of zipped documents are not allowed.
- d. Applicable penalties that include but not limited to voided Application, blacklisting of companies, forfeiture of statutory fees paid and liable to prosecution shall apply for the use of forged and/or fake documents, any attempt to circumventing the process or inducement of staff etc.

3.2.2 Document Requirements for General, Major and Specialised Category

The following documents shall be uploaded for all category of applications:

- a. Certificate of Incorporation or Certificate of Registration (for an Enterprise). The following shall be noted:
 - i. Companies registered as enterprises (unincorporated companies) can apply for and be issued permit under General Category and certain services in Major Category such as Legal, Architecture, Quantity Surveying, State/ property management, Accounting/Auditing, Taxation, QA/QC etc.
 - ii. Companies registered as enterprises (unincorporated companies) will not be accepted for services in the specialised category.
 - iii. Foreign companies shall possess proof of exemption from Ministry of Trade and Investment in line with the section 80 CAMA Act 2020 and filings with CAC.
- b. Form C.07/CAC 7/CAC 2.3 or copies of CAC forms 7.6, 6 & 2. The details of the Directors shall be same as filled on the portal.

c. Company's current Tax Clearance Certificate or Income Tax Certificate (for Enterprises).

The following shall be noted:

- i. Federal Inland Revenue Services (FIRS) Tax Clearance Certificates (TCC) are acceptable for Limited Liability and Public Liability Companies
- ii. Personal Income Tax clearance (issued by States) of Chief Executives are valid for Unincorporated Companies (Business names registrations, Partnerships, Sole Proprietorships, Enterprises, etc.).
- iii. Tax Clearance Certificates (TCC) uploaded in applications during the preceding permit year remain valid and acceptable **until 31st March of the new permit year**, in line with the Federal tax laws.
- iv. The address on the Tax Clearance Certificate should correspond with either the provided address on the company's application profile (operational address) or address on the company registration documents.

d. Employee's compensation scheme (Nigeria Social Insurance Trust Fund-NSITF). The following shall be noted:


- i. Nigeria Social Insurance Trust Fund (NSITF) payment registration uploaded in applications during the preceding permit year remain valid and acceptable.
- ii. Applications shall be submitted with a valid NSITF certificate or payment receipt.

e. Certified true copy of Memorandum & articles of Association (This applies to Limited Liability Companies).

3.2.3 Additional Documents for Major and Specialised Category

The following additional information may be required for all Major and Specialised Category of applications:

- a. Registrations by relevant Professional/ Certification body. The following shall be noted as may be applicable:
 - i. All permit holders are encouraged to be members of professional bodies related to the service they intend to provide.
 - ii. Companies maybe be required to submit duly issued instruments (licenses, permits and approvals) by recognized Regulators/Institutions/ Associations in that field, which are subject to verification.
- b. Key staff of the Organisation are required to be members of Professional Organisation or possess relevant certificates or certifications related to their job function.
- c. List of relevant Equipment where applicable. The following shall apply.

- i. This list and description the equipment shall be submitted on a company letter head. Pictures should be provided where possible.
- ii. The list of equipment to be uploaded should be **ONLY** those relevant/essential/unique for the service being applied.
- iii. Technical agreement with company or MOU with Nigerian company may be accepted.
- d. Companies that want to render the service of security and surveillance using unmanned aerial vehicles (drones) shall need approval from the Nigerian civil Aviation Authority (NCAA) and the Office of the National Security Adviser (ONSA).

3.3 Procedure for the Review and Processing of Applications

Application processing involves as follows where applicable.

- i. Desktop Review of application after submission.
- ii. Accreditation and Inspection of facilities and process as may be necessary.

3.3.1 Review of MDOGISP Applications.

The following apply to the review of submitted applications:

- i. Applications will be processed within three (3) working days. However, major, and specialized categories may be subject to further validation evaluation which may exceed the three days stipulated.
- ii. Applications may be returned to company upon review, for various reasons which includes; request for reupload of documents, provision for additional information and correction of customer's information etc.
- iii. Once an application has been submitted, Companies will be unable to change/replace/modify documents after submission. Requests for any change must be made to the Authority Chief Executive by email via the MDOGISP official email stipulated in Section 2.6.
- iv. Required documents must be uploaded on the assigned labelled upload pane (box). Upload panes are made available to provide additional documentation.
- v. Company contacts and operational addresses are mandatory requirements.
- vi. Any addresses supplied by the company may require verification through a request for upload of documents such as utility bill.

3.3.2 Inspection and Accreditation Processes


The following applies:

- a. Inspection, Accreditation, and process validations of facilities may be carried out on selected services for new and renewal applications under the specialized categories.
- b. Where Inspection, Accreditations and process validations of facilities are required, the inspections can be conducted without notice and without prejudice to existing MDOGISP the company may possess.
- c. The inspection shall cover:
 - i. Validation of company documents
 - ii. Condition of equipment and facilities
 - iii. Other requirements as may be specified in the guidelines and checklist made available by the NMDPRA.

3.3.3 Mandatory Accreditation Processes

The following shall apply:

- a. Notwithstanding the issuance of a permit, the accreditation of the following facilities used for the following permits are mandatory.
 - i. Safety training centres
 - ii. Lab services

- iii. Waste management Services
- b. Such accreditation must be carried out prior to the use of those facilities for operations.
- c. Accreditation certificate or Operational approval shall be issued for such service.
- d. Failure to carry out the above shall attract sanctions.

3.4 Issuance and Validity of Permits

The following applies:

- i. Permits shall be issued upon satisfactory outcome of Desktop review and inspections as may be applicable.
- ii. All permits issued pursuant to these Guidelines shall expire on the anniversary of the date of issue as reflected on the permit.
- iii. Permit(s) issued by the NMDPRA with respect to MDOGISP can be viewed online in line with Section 2.5 of the Guidelines or may be printed by the Service Provider from its MDOGISP profile.
- iv. Any modification or subsequent change(s) on any issued permit shall require a new application.
- v. Notwithstanding the issuance of service permit by NMDPRA, to a prospective Service Provider, the Licensee/Operator is expected to independently evaluate the Service Providers for the intended service prior to engagement.
- vi. The NMDPRA shall not be liable or requested to provide indemnity for failure of a service provider for deliver on services for permit issued NMDPRA.

3.5 Renewal of MDOGISP

The following shall apply:


- i. All permits shall be renewed on expiry.
- ii. Renewal of applications shall be open four (4) weeks before expiration of the permit.

4 MDOGISP SERVICE DELIVERY REQUIREMENTS

4.1 Engagement of Service Providers by Licensee/Operators

The following shall apply at the minimum:

- a. Licensee/Operators wishing to engage any service provider shall ensure its internal processes for engagement of service providers.
 - i. Contain procedures that are fair, transparent, and non-discriminatory and does not encourage anti-competitive behaviour.
 - ii. Follow due diligence and standard process in evaluating technical capability of the service provider to carry out the service.

- b. The Operator/licensee shall carry out all the duties of manager stipulated in the Petroleum Safety Regulations and has principal responsibility for the safety of the service providers engaged in its operations.
- c. A licensee/Operator shall be responsible for ensuring that the service provider complies with all the statutory requirements stipulated by the NMDPRA in its operations.
- d. A Licensee/Operator shall establish formal systems for engagement of service providers under its operations. The forum/system is expected to provide platforms for the Licensee/Operator:
 - i. To offer feedback directly to the management of the Service providers.
 - ii. Share lesson learnt, best practices and other information with service providers.
- e. Licensees and Operators shall establish process for providing feedback to the service provider for continuous improvements in service delivery:
 - i. On its performance and service delivery and supply such information on demand in the format/platform the NMDPRA may prescribe.
 - ii. The Feedback offered to the Service provider by the Licensee/Operator shall, as applicable, cover at a minimum standard stipulated in Section 4.2.


4.2 Minimum Service Performance by Service Providers

All Service providers shall ensure that its processes and service delivery charter for the operator/licensee cover the following area.

4.2.1 HSE Performance

All Service Providers shall ensure its management commitment to HSE in all its operations. As applicable, the Service Provider shall ensure:

- a. An established HSE policy and systems for the company which shall form the basis of establishing a HSE bridging document while being engaged to carry out activities for the Licensee/Operator.
- b. HSE trainings and refreshers are carried out for its workforce as required.
- c. Awareness and the use of appropriate PPE by its workforce.
- d. The use of standard operating Procedure (SOP) to carry out all activities.
- e. System for reporting, documenting and management of unsafe acts, near-misses dangerous occurrence and accidents. All incidents shall be reported to the licensee as soon as possible. NMDPRA may from time to time provide platforms for reporting.
- f. The workforce understands and can perform as applicable:

- i. Job Safety Analysis, risk assessment and other safety measures required for activities.
- ii. Permit to Work.
- iii. Exercise Stop Work Authority
- iv. Basic safety requirements as applicable, etc

4.2.2 Technical Capacity

All Service Providers shall establish within their organisation processes for keeping up-to-date technically and technologically. The work system established by the Service Provider shall ensure:

- i. Clear line of reporting, hierarchy and cooperative working relationships amongst its workers.
- ii. Supervisor's competence for all activities.
- iii. Information are obtained from relevant sources and a system for the incorporation of new knowledge for the improvement of working procedure.
- iv. Established system for communicating and handling of feedback by management for continuous improvement.
- v. Established system for coaching and training for the continuous improvement of competence for its workforce.

4.2.3 Equipment


The service provider shall ensure the use relevant equipment that are in quality conditions for service delivery. The service provider equipment shall ensure:

- i. The use of approved and standard checklist for proper inspection of equipment.
- ii. The inspection of equipment as at when due, In line with manufacturers recommendations, regulations, and international recognised standards.
- iii. The use of appropriate parts for the servicing and repairing of the equipment,
- iv. Proper calibrations are carried out on the equipment as when due,
- v. Appropriate spares are maintained for the equipment to reduce possible downtime in service delivery to the Operator/Licensee.

4.2.4 Quality of Service

In the course of service delivery, service providers shall emplace and operate a processes that ensure the delivery of quality service to the Operator. It shall ensure the following:

- i. Professionalism in its service delivery as a company to the licensees/operator.
- ii. Accomplishment of task within an agreed timeframe with the Operator/Licensee,
- iii. Proper housekeeping in and around its work area.

- iv. Optimization & organization of operations to minimize time wastages, elimination of shoddy jobs and rework.

4.2.5 Documentation and Reports

All service companies shall have documentation systems for easy retrieval of information. It shall ensure as follows:

- i. Established systems for maintaining information files and processing paperwork for easy retrieval.
- ii. Documented standard working documents for all process and work activities.
- iii. Detailed instructions, drawings, or specifications are used to carry out all activities.
- iv. The accuracy and quality of reports that is capable of providing guidance and expert advice to the Operator/Licensee.

5 SANCTIONS

Non-Compliance With the Requirements of these Guidelines shall be deemed as violations to relevant sections of the Petroleum Industry Act 2021 and Regulations pursuant to the Act. These violations may result in applicable consequence management, including but not limited to, fines, penalties, revocation of permit and/or blacklisting of service provider. These Guidelines is subject to review without notice.
